Sub: Fare structure of AC EMU/DEMU/MEMU.

In continuation of above Commercial Circulars, Ministry of Railways have further decided that the currency of introductory offer for fare of AC EMU/DEMU/MEMU service shall be extended further up to 31.05.2019.

2. Accordingly, the base fare of single journey of AC EMU/DEMU/MEMU shall be charged 1.2 times of the base fare of existing single journey tickets for First class tickets.
3. There shall be no change in other terms and conditions.
4. CRIS is requested to make necessary changes in the software.
