It has come to the notice of Ministry of Railways that while issuing tickets against Police Warrants, certain charges other than fare like reservation fee, superfast surcharge, etc., are being realised in cash by Railways (.) Ministry of Railways have examined the matter and decided that nothing should be collected in cash from the concerned personnel while issuing tickets against Police Warrants (.) The total cost of the ticket, including all surcharges and reservation fee shall be debited to the respective organisations (.)
