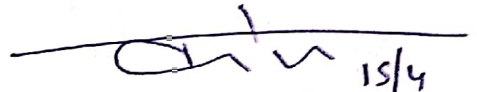

- 1.0 In terms of Board's letter referred at (i) above, Northern Railway has forwarded proposal with due approval of the General Manager to include **Khurja Jn. (Incl.) (KRJ) - Hapur (HPU) Section of Moradabad division** of Northern Railway in the CC+8 routes.
- 2.0 Please refer to Annexure III of Rates Master Circular under reference at (ii) above, wherein list of CC+8 routes is prescribed. Now, sanction of the competent Authority is hereby accorded to include **Khurja Jn. (Incl.) - Hapur (KRJ-HPU) Section of Moradabad division** of Northern Railway in the list of already indentified CC+8 routes.
- 3.0 All other details of the Rates Master Circular & Corrigenda thereto under reference shall continue to apply unchanged.
- 4.0 These instructions shall come into effect from 15 .04.2020 and shall remain valid till further advice.

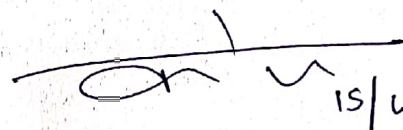
