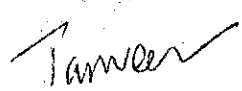

(ii) In rule 260.3, the text of the certificate from "I heretoby -----per year" may be revised as under:

"I, hereby certify that Shri/Shrimati/Kumari is the Member of Madhya Pradesh Legislative Assembly and tickets may be issued in exchange of rail travel coupons for journeys to be undertaken by him/her alone or with one person accompanying him/her subject to the conditions mentioned under these rules."

(iii) The Note appearing under rule 260.16, alongwith its contents, may be deleted.
