Sub: Delegation of powers to the Zonal Railways to decide for the applicability of 10 Kg. tolerance limit only for Thermocol Boxes loaded with fish.

REF: (i) Board's Freight Marketing Circulars No. 12 of 2007 dated 30.03.2017 and No. 05 of 2008 dated 31.03.2008.

In order to attract additional fish traffic and to augment parcel/luggage traffic on Indian Railways, it has been decided to delegate powers to Principal Chief Commercial Managers to decide for the applicability of 10 Kg. tolerance limit only for Thermocol Boxes loaded with fish.

2. Other terms and conditions for booking of fish will remain the same.
3. These instructions shall be effective from 15.04.2018.
