Sub:- Delegation of powers to the Zonal Railways to decide reduction in luggage allowance of Card Ticket holders to the level of Season Ticket holders.

In reference to the above, it has been decided to delegate powers to Principal Chief Commercial Managers of the Zonal Railways to decide 'reduction in luggage allowance of Card Ticket holders to the level of Season Ticket holders, i.e. 15 kgs and 10 kgs for first class and second class respectively, over Suburban sections during peak periods, based on local conditions'.
