A copy of such a fake identity Card which has been detained by Vigilance Department, Central Railway is enclosed for information.

In order to prevent misuse of identity cards issued to Members of Parliament, a specimen copy of identity card issued to Members and their Spouse for railway journey, issued by Rajya Sabha Secretariat is enclosed. The proper format of the identity card and the authority for issue of the same may be given wide publicity and the concerned staff may be made aware of the extant facility available to Members of Parliament.
