Sub: Policy instructions regarding 'Jan Shatabdi' Express .

Jan Shatabdi Express trains with characteristics of Shatabdi Express trains having Second Class and AC Chair Car accommodation have been introduced/will be introduced on Zonal Railways. The II/SL class pass holders have been permitted to travel on Second Class accommodation by these trains on their Duty/Privilege/Post-retirement Complimentary Passes vide Establishment Directorate's letter No. E(W)2000PS5-1/17 dated 31.5.2002, a copy of which is enclosed.

Since, these trains have been introduced on the pattern of Shatabdi Express trains, it has been decided that separate reservation quota as "Duty Pass Quota" should be earmarked for Duty/Privilege/Post-retirement Complimentary Pass holders by 'Jan Shatabdi' Express trains in both the classes i.e. Second Class and AC Chair Car. Out of the 'Duty Pass' quota so earmarked, 50% of the quota will be available at the counter for bookings on first come first served basis and the remaining 50% will be operated as Emergency Quota. The number of seats to be earmarked as Duty Pass Quota in these classes will be decided by the Zonal Railways keeping in view the composition of the trains. Action taken in the matter may be advised to this office.

विषय : "जन शताब्दी " एक्सप्रेस से संबंधित नीति अनुदेश.

शताब्दी एक्सप्रेस गाड़ियों की जैसी ही विशेषताओं वाली जन शताब्दी एक्सप्रेस गाड़ियां, जिनमें द्वितीय श्रेणी/वातानुकूल कुर्सीयान उपलब्ध होंगे, क्षेत्रीय रेलों पर शुरू की गई हैं/शुरू की जानी हैं. स्थापना निदेशालय के दिनांक 31.5.2002 के पत्र सं. ई (डब्ल्यू) 2000 पीएस 5-1/17, जिसकी एक प्रति संलग्न है, के द्वारा द्वितीय/शयनयान श्रेणी के पास धारकों को उनके ड्यूटी/सुविधा/सेवानिवृत्ति उपरांत मानार्थ पासों पर इन गाड़ियों की द्वितीय श्रेणी में यात्रा करने की अनुमति दी गई है.

चूंकि इन गाड़ियों को शताब्दी एक्सप्रेस गाड़ियों के पैटर्न पर ही शुरू किया गया है इसलिए यह विनिश्चय किया गया है कि ड्यूटी/सुविधा/सेवानिवृत्ति उपरांत मानार्थ पास धारकों को 'जन शताब्दी' एक्सप्रेस की दोनों श्रेणियों अर्थात् शयनयान और वाता.कुर्सीयान में "ड्यूटी पास कोटा" के रूप में एक पृथक आरक्षण कोटा निर्धारित किया जाए. इस प्रकार निर्धारित किए गए 'ड्यूटी पास कोटे' में से 50% पहले आओ पहले पाओ के आधार पर बुकिंग के लिए काउंटर पर उपलब्ध होगा और शेष 50% कोटा आपातकालीन कोटे के रूप में परिचालित किया जाएगा. इन श्रेणियों में ड्यूटी पास कोटा के रूप में निर्धारित सीटों की संख्या का विनिश्चय गाड़ियों की संरचना को ध्यान में रखते हुए क्षेत्रीय रेलों द्वारा किया जाएगा. इस मामले में की गई कार्रवाई की सूचना इस कार्यालय को भेजे.

**Sub: Entitlement of travel by Jan Shatabdi Express trains on Duty/
Privilege/Post-retirement Complimentary Passes.**

Jan Shatabdi Express trains with characteristics of Shatabdi Express trains have been introduced on certain routes. These trains will have specially designed Second Class and AC Chair Car accommodation. It has, therefore, been decided by Board that W/SL class pass holders may be allowed Second Class sitting accommodation by Jan Shatabdi Express trains, on their Duty/Privilege/Post-retirement Complimentary Passes, as under:

Duty Pass : One seat

Privilege/Post-retirement Complimentary Pass : Two seats

2. The entitlement of I Class and I-A Pass holders on their Duty/Privilege/Post-retirement Complimentary Passes, shall be the same as provided in Board's letters of even number dated 09.06.2000 & 07.09.2000.
3. These instructions may be brought to the notice of all concerned.
