Copy forwarded to GSARCA, Chelmsford Road, New Delhi for issue of necessary correction slip to Coaching Tariff No. 25, Part I (Vol. II). The correction slip may be issued as under:-

(i) In S.No. 4, Note (1) in Col. 3, page 19, the words "However, the tickets ----- the concession order" "परन्तु विद्यार्थियों द्वारा ----- खरीद लिये जान चाहिये" may be deleted.

(ii) At the bottom of Appendix 1/14 (page 161), Appendix 1/38 (page 197), Appendix 1/39 (page 202) and Appendix 1/49 (page 225), for the sentence "This certificates is valid-----for the return journey", substitute "For purchasing tickets, this certificates is valid for fourteen days from the date of issue for outward journey and for three months for the return journey."
