No.TCII/2256/82/1 (.) As per rule 249 of IRCA Coaching Tariff No. 26, Part I (Vol. I), the Members and ex-Members of Bihar State Legislature are entitled to purchase tickets through Coupons when travelling alone or with any one companion for travel anywhere within India, by trains in AC First, AC 2-tier and AC 3-tier classes only subject to certain conditions (.) On the request from Bihar Vidhan Sabha Secretariat, Ministry of Railways have decided that tickets against coupons may be issued to Members of Bihar State Legislature with maximum four companion & to ex-Members of Bihar State Legislature, with maximum three companion in AC First, AC 2-tier and AC 3-tier classes only subject to other conditions. However, in so far as emergency quota is concerned, only Member of Legislative Assembly plus one shall be considered subject to availability (.) Necessary instructions may be issued to all concerned immediately (.) This issues with the concurrence of Finance Directorate of Ministry of Railways (.)
