Sub: Catering services on Jan Shatabdi express.

Ref: 1. Board's letter of even no. dated 5/7.4.2002

2. IRCTC's letter No. 2002/IRCTC/Catg./Jan Shatabdi dt. 11.4.02.

In continuation to Board's letter of even number dated 5/7.4.02 the suggestions given by IRCTC vide their letter quoted above have been examined in Board's office and following clarifications are issued.

1. Jan Shatabdi services are of different class and there can not be any comparison with Rajdhani/Shatabdi trains. Deluxe menu was withdrawn as there were complaints of over charging on some railway.
2. As regards para 1 and 2 of the IRCTC's letter, IRCTC in consultation with Zonal Railway may workout the menu which should be reflective of unit cost specified, as indicated in para 3 of Board's letter quoted above. However, the Annexure 'A', which was sent along with the Board's letter may be replaced with Annexure 'A' (revised) as the menu suggested for Lunch/Dinner for non AC Class was inadvertently given on the basis of Thali meal whereas it should be as per casserole meals in trains.
3. Regarding last para of IRCTC's letter it may be mentioned that the rates specified for Jan Shatabdi are based on prevailing rates of meals specified for other mail/express train. IRCTC may test the market by inviting open tenders.
