Sub: Concession to sports persons. Ref: CC No.58 of 2017 dt.01.08.2017

As per S. Nos. 1 & 2 of annexure to Rule 101 of IRCA Coaching Tariff No. 26, Part I (Vol. II), Sportspersons participating in tournaments are eligible for rail travel concession as per rule. Ministry of Youth Affairs & Sports, Govt. of India, vide letter No.9-12/2017-SP-I dt. 03.01.2018 has advised that the recognition of the following sports federation have been suspended or withdrawn for the year 2018 due to some dispute. In this case, concession to sports persons will be granted on concession certificate issued by the Secretary Sports Authority of India or Executive Director (Teams) from Sports Authority of India, Jawaharlal Nehru Stadium Complex, Lodhi Road, New Delhi in place of the following federations mentioned below:

As advised by Ministry of Youth Affairs and Sports, Ministry of Railways have decided that in place of the following existing Sports federations, concession in the Railway fare shall be admissible on the concession certificate issued by Sports Authority of India only.

It may be ensured that concession is granted to the above sports persons only on production of certificates from the Secretary Sports Authority of India or Executive Director (Teams) from Sports Authority of India, Jawaharlal Nehru Stadium Complex, Lodhi Road, New Delhi only.

As advised by Ministry of Youth Affairs and Sports, Ministry of Railways have decided that the following Sports federations, which were suspended vide CC No. 58 of 2017 dt. 01.08.2017 have been recognized to issue concessional certificate in respect of their sports players. Accordingly, authority given to Secretary, Sports Authority of India or Executive Director (Teams) from Sports Authority of India should be treated as withdrawn in respect of the following Sports Federations.
