

**Sub: Revision in Circular Journey Ticket (CJT) - Rule No.205 of IRCA  
Coaching Tariff 26, Pt.I(Vol-1)**

In order to bring more clarity in rule of circular journey ticket when the distance between two break journeys for route is more than 15%, it is proposed to revise Note of Rule No.205 of IRCA Coaching Tariff 26, Pt.I(Vol.-1) Circular Journey Ticket(CJT) as under:-

“If tickets are issued to passengers by other than normal and reasonably direct routes which is longer than 15% of the shortest route, then on such distances the telescopic benefit would not be applicable and normal fare would be applicable from point to point between that particular two break journeys.”

2. This issues with the concurrence of the Finance Directorate of the Ministry of Railways.


