Sub : Levy of Congestion Surcharge for traffic booked to Bangladesh.

- (i) Rates Circular No.23 of 2015 (incorporated in Rates Master Circular/Dynamic Pricing Policy/2015/0);
- (ii) Corrigendum No.4 to Rates Circular No.23 of 2015 dated 05.03.2019.

- 1.0 In terms of para 3.0 of Rates Circular No.23 of 2015, Congestion Charge, on all traffic booked for Bangladesh, is leviable @ 25% of the applicable Base Freight Rate. (incorporated in Rates Master Circular/Dynamic Pricing Policy/2015/0).
- 2.0 Further in terms of Corrigendum No.4 to Rates Circular No.23 of 2015 dated 05.03.2019 levy of Congestion Surcharge for Stone traffic transported from Eastern railway to Bangladesh via Darsana/Benapole was withdrawn till further advice.
- 3.0 Matter has been reviewed and the Competent Authority have decided to discontinue the waiver of levy of above Congestion Charge for Stone traffic transported from Eastern Railway to Bangladesh.
- 4.0 These instructions shall come into force w.e.f. 01.10.2020 and shall remain valid till further advice.
- 5.0 All other details of the circular under reference shall remain unchanged.
- 6.0 This issues in consultation with Traffic Transportation Directorate and with the concurrence of Finance Directorate of Ministry of Railways.
