Sub: Running of freight trains on CC+8 routes.

Ref : (i) Board's letter No.2018/E&R/1(8)/4 dated 24.04.2018.

(ii) Rates Master Circular/PCC/2019/0 dated 16.05.2019 & Corrigenda thereto.

- 1.0 In terms of Board's letter referred at (i) above, South Western Railway has forwarded proposal with due approval of the General Manager to include routes (a) Tumakuru (TK) – Arsikere (ASK) – Chikjajur (JRU) i.e. Tumakuru to Gubbi (both up & down line), Gubbi to Kardi (Single line section) & Kardi to Chikjajur (both up & down line); & (b) Amaravathi Colony (AVC) – Harihar (HRR) – Hubballi (UBL) i.e. Amaravathi Colony to Harihar (both up & down line), Harihar to Hubballi (single line) in the CC+8 routes.
- 2.0 Please refer to Annexure III to Rates Master Circular under reference wherein list of CC+8 routes is prescribed. Now, sanction of the Competent Authority is hereby accorded to include (a) Tumakuru (TK) – Arsikere (ASK) – Chikjajur (JRU) i.e. Tumakuru to Gubbi (both up & down line), Gubbi to Kardi (Single line section) & Kardi to Chikjajur (both up & down line); & (b) Amaravathi Colony (AVC) – Harihar (HRR) – Hubballi (UBL) i.e. Amaravathi Colony to Harihar (both up & down line), Harihar to Hubballi (single line) of South Western Railway in the list of already identified CC+8 routes.
- 3.0 All other details of the Rates Master Circular & Corrigenda thereto under reference shall continue to apply unchanged.
- 4.0 These instructions shall come into effect from 26.01.2020 and shall remain valid till further advice.
- 5.0 This issues with the concurrence of Finance Directorate of Ministry of Railways.
