South Western Railway	Birur (RRB) – Shivamogga Town (SMET)

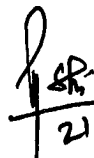

4.0 All other details of the Rates Master Circular & Corrigenda thereto under reference shall continue to apply unchanged.

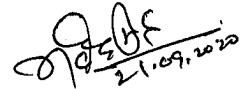
5.0 These instructions shall come into effect from 23.09.2020 and shall remain valid till further advice.

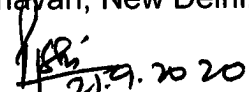

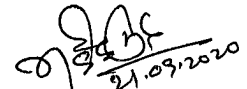
