G.S.R. 680(E).—In exercise of the powers conferred by Section 31 of the Cigarettes and Other Tabacco Products (Prohibition of Advertisement and Regulation of Trade and Commerce, Production, Supply and Distribution) Act, 2003 (34 of 2003) the Central Government hereby amends the Prohibition of Smoking in Public Places Rules, 2008, namely:—

- (1) (i) These rules may be called the Prohibition of Smoking in Public Places (Amendment) Rules, 2009.
- (ii) They shall come into force on the date of their publication in the Official Gazette.
- (2) In Schedule III to the Prohibition of Smoking in Public Places Rules, 2008, after serial number 12 and the entries relating thereto, the following serial numbers and entries shall be inserted, namely:—
