**Sub: Installation of ATMs at Railway Stations - Clarifications**

ATMs have been installed at Zonal Railways as per provision of MoU signed by Ministry of Railways with State Bank of India and other Banks. Clarifications have been sought by certain Zonal Railways on this account. The matter has been examined and the position is clarified as under:-

Sl. No.	Zonal Railway	Clarification sought	Comments
1	North Central Railway	Railway has requested for granting permission to install ATM at Banda Station by Punjab National Bank whereas Banda was not figuring in any of the lists approved by Board's office.	The license fee fixed for installation of ATMs by Banks as per MoU is on the lower side as it was a package deal for installation of ATMs both at big as well as small stations. Hence, more ATMs should not be installed as per provision of MoU and Zonal Railways may go for tender process for this purpose. However, if the Railways get a proposal from the Banks for similar package deal, the same can be forwarded to Board's office for taking a final decision.
2	Northern Railway	Zonal Railway may be allowed to add more Stations on the same terms and conditions as envisaged in the MoU.	
3	East Central Railway	ATM installation may be permitted on "first come first serve basis" after taking adequate security from the Banks.	
4	South Central Railway	South Central Railway could not provide power supply to State Bank for installation of ATMs due to which the commissioning of some of the ATMs was badly delayed. Accordingly, SBI has requested to reckon the annual license fee from the date of electricity supply by Railways. South Central Railway has requested Board's office to consider the plea of SBI.	Since the cause of delay in installation of ATMs lies solely with Railways, the date of payment of annual license fee for such ATMs may be reckoned from the actual date of providing of electricity connection in these cases only.

5	Southern Railway	The Railway has advised that the licence fee has been fixed according to the category of Railway Station at the time of allotment/signing of agreement with the Banks. Based on the earnings of 2006-07, the revised category of Railway Stations has been enforced w.e.f. 1.4.2008. The Railway has sought clarification whether enhanced licence fee based on revised category of Railway Stations w.e.f. 1.4.2008 may be collected from the Banks during the current year of existing contract period.	Licence fee will be realised on the basis of actual category of Station at the time of signing of MoU i.e. November 2006.
