Reference above, the matter has been relooked into and the Competent Authority have decided for levy of 5% supplementary charge for Two Point Rakes of steel traffic.

Accordingly, Para 2.0(a1) is hereby inserted below Para 2.0(a) of Corrigendum No.11 dated 24.12.2020 as under:

Para 2.0(a1): The word "7.0" appearing in above para (a) is hereby deleted. Besides other conditions mentioned in Para 7.0 of Rates Master Circular on Block Rakes/Mini Rake/Two Point Combination etc./2020, the Two point rakes (other than covered wagons) for steel traffic as stipulated under Para 7.0 and notified at Annexure-IIof Rates Master Circular on Block Rakes/Mini Rake/Two Point Combination etc./2020 as modified from time to time shall be allowed subject to levy of Supplementary Charge @5%.

All other details, of the reference above, shall remain unchanged.

This issues in consultation with Traffic Transportation and with the concurrence of Finance Directorate of the Ministry of Railways.
