
1. A proposal for fixation of Permissible Carrying Capacity (PCC), Loading Tolerance, Standard Rake Size, Minimum number of wagons to be loaded and Designed Tare Weight for BFNV wagons was under consideration of Board.
2. The matter has been examined, and it has been decided by the Competent Authority that for the purpose of charging "BFNV" wagon, Permissible Carrying Capacity (PCC) and Loading Tolerance (refer Rates Master Circular/PCC/CC+8 etc./2020/0) shall be as under:


Routes	Excepted CC+6	Universalized CC+6	CC+8
PCC	65 Tonne	66.5 Tonne	68.5 Tonne
Loading Tolerance	1 Tonne	1 Tonne	1 Tonne

3. The Standard Rake Size, Minimum number of wagons to be loaded for BFNV wagon (refer Rates Master Circular on Block Rakes/Mini Rake/Two Point Combination etc./2020/0) shall be as under:

Type of wagon	Standard Rake Size	Minimum number of wagons to be loaded
BFNV	58	57


4. The Designed Tare Weight of BFNV wagon (refer Rates Master Circular/Weighment/2019/0) shall be 22 Tonne.
5. All other instructions of Rates Master Circulars referred above shall remain the same.
