Ref: Rates Master Circular/PCC/CC+8 etc/2020/0 and corrigenda thereto.


1. In terms of Annexure-I to Board's Rates Master Circular/PCC/CC+8 etc/2020/0 and corrigenda thereto, Permissible Carrying Capacity (PCC) and Loading Tolerance of various wagons have been notified.

2. The issue has been examined. It has been decided by the Competent Authority that the Permissible Carrying Capacity (PCC) and Loading Tolerance of BCN, BCNA & BCNAHS and BCNHL wagons on various routes, when loaded with the commodity "Rice" and "Wheat" (Group No. 9. Foodgrains, Flours and Pulses) shall be as under:
