

Extant guidelines regarding operation of container trains by Private Container Operator (PCO) in railway owned terminals are prescribed vide Chapter-I of Rates Master Circular/CRT-CCR-Hub&Spoke/2015/0 and subsequent amendments thereto.

In terms of Corrigendum to Rates Circular No.11 of 2021, the permission for operation of container trains by Private Container Operator(PCO) in railway owned terminals notified as Container Rail Terminal (CRT) is valid upto 31.12.2021.

The matter has been reviewed and it has been decided to extend the currency of extant instructions regarding operation of container trains by Private Container Operators (PCO) in railway owned terminals notified as Container Rail Terminal (CRT) **beyond 31.12.2021 till 31.03.2022.**

This issues in consultation with Traffic Transportation Directorate and with the concurrence of Finance Directorate of Ministry of Railways.




